

# REQUEST FOR MEDIATION

This Request is submitted to the Arbitration and Mediation Center of Armenia for the purpose of conducting mediation



According to Article 2, Part 2.1 of the Law on Mediation of the Republic of Armenia, mediation is mandatory prior to applying to court in cases concerning divorce, determination of the child's place of residence, recovery of alimony, division of property considered joint marital property, matters related to contact with the child, upbringing and education of the child, exercise of parental rights, determination of visitation arrangements, and modification or termination of a prenuptial agreement, except for the cases provided in Part 5 of this Article.

**This application form is intended for cases of mandatory mediation to be submitted to the Arbitration and Mediation Center of Armenia.**
